



Public Disclosure:
Pontifical College Josephinum status changed
from “Accredited” to “Accredited – On Probation”
Effective: June 23, 2022

The Higher Learning Commission has placed Pontifical College Josephinum in Columbus, Ohio on Probation. HLC took this action because it determined that the institution is out of compliance with HLC requirements.

The initial period of Probation is not more than two years. Probation affords an institution a reasonable period to address HLC’s concerns. While on Probation, the institution remains accredited, and it has the opportunity to remedy the issues that led to the sanction.

What This Means for Students

In most cases, other colleges and universities will continue to accept the institution’s credits in transfer or for admission to a higher degree program. All colleges and universities define their own transfer and admission policies. Students interested in pursuing a higher degree or transferring should contact the college or university they plan to attend so they are knowledgeable about admission and transfer policies for that college or university.

Noted HLC Requirements

HLC concluded that the institution Does Not Meet the following HLC requirements:

- Criterion 2, Core Component 2.A, “Integrity”
- Criterion 2, Core Component 2.B, “Transparency”
- Criterion 3, Core Component 3.A, “Degree Programs Appropriate to Higher Education”
- Criterion 5, Core Component 5.A, “Effective Governance and Administrative Structures”
- Criterion 5, Core Component 5.C, “Systematic and Integrated Planning and Improvement”

HLC concluded that the institution Meets with Concerns the following HLC requirements:

- Criterion 3, Core Component 3.B, “Exercise of Intellectual Inquiry Integral to Programs”
- Criterion 4, Core Component 4.A, “Program Review”
- Criterion 4, Core Component 4.C, “Persistence, Retention and Completion”
- Criterion 5, Core Component 5.B, “Resource Base”

Next Steps

The institution is required to provide evidence that it has addressed the issues that led to the sanction, no later October 1, 2023 in preparation for HLC’s on-site evaluation to be held no later than December 2023. In June 2024, the HLC Board of Trustees will determine whether the institution has demonstrated that it is in compliance with HLC requirements and whether Probation can be removed.
